NIGHT RIDE ON THE WITHLACOOCHEE STATE TRAIL

Location: The ride begins and ends at Suncoast Bicycle, 322 N. Pine Ave, Inverness, at the North Apopka Avenue trailhead of the Withlacoochee State Trail. **There is no mass start.**

Distance: Approximately 30 miles. The ride heads south to the Floral City/Istachatta trail marker, then back to Inverness. Riders can choose to ride a shorter distance by turning around in downtown Floral City and returning to Inverness (approximately 15 miles).

Refreshments: Food & refreshments will be served following the ride at Suncoast Bicycles.

Entry Fee: Pre-registration is \$15 per rider through October 9. Pre-registered riders will receive a t-shirt. Registration is \$20 after Oct. 9, and you're not guaranteed a shirt.

Other Details All riders are **strongly encouraged** to wear helmets, and must have front and rear lights mounted on participating bikes. Children must be accompanied by an adult. Proper trail etiquette must be followed.
